

## TOUR PARTICIPANT AGREEMENT

This agreement contains the terms and conditions by which World Wide Kosher Inc., (operator), a corporation, in consideration of the participant's agreement, agrees to arrange the services listed in the tour brochure.

The participant acknowledges that neither the Operator nor its agents have made any representations or promises other than those described and set forth. Participant agrees not to hold operator liable for any circumstances beyond its control.

The operator may decline for any reason, any person(s) as a participant on the trip, whereupon the only obligation of the operator is to provide a refund to such person(s) of paid fee for unused services. Operator reserves the right to withdraw at any time any program announced in this brochure and/or to make such alterations as it may deem appropriate in its sole discretion.

**PAYMENT SCHEDULE:** DEPOSIT OF \$1,000 per person per room, \$1,500 per person per suite is required, as well as a signed Participant's Agreement to hold any reservation. FINAL PAYMENT will be due 60 days prior to beginning of tour. Full payment received less than 60 days prior to scheduled date of arrival will be subject to a surcharge of \$50.00 per person. This charge covers the additional costs incurred in processing late reservations. Please reserve early and submit payments timely to avoid this surcharge. Any disputes arising over monies will be adjudicated in a Bais Din Arbitration forum.

**CANCELLATIONS:** Full refund less the deposit paid for the room reservations will be made if you cancel 45 days prior to your scheduled date of arrival. If you cancel 30-44 days prior to your scheduled date of arrival you will receive a refund of 50%, 16-29 days, a refund of 25% and 15 days or less, no refund. All cancellations must be received in writing, via certified mail with return receipt requested. Your reservation and deposit confirm that you have read, understood, and agreed to each and all of the above conditions and limits on responsibility.
